Thrive grants support organisational capacity building and acknowledges the importance of smaller, grass-roots charitable organisations, supporting them to do what they do better in the Foundation's Impact Areas. Grants are available to organisations working in one of the Foundation's four key Impact Areas including Education & Employment (various rounds open throughout the year, up to \$40,000, eligibility - DGR and TCC status required).

Proactively helps young people break out of the cycle of disadvantage through educational interventions. The current focus is to fund early stage interventions in education (always open, unspecified amount).
